

**MINUTES: April 2015 District Judge's Conference
April 30 and May 1, 2015
Cody, Wyoming**

The regular meeting of the District Court Judge's Conference was called to order on April 30, 2015. The meeting was held in the District Courtroom, Cody, WY. Those in attendance included: Judges Bluemell, Brooks, Campbell, Cranfill, Deegan, Donnell, Edelman, Fenn, James, Kautz, Perry, Sharpe, Sullins, Tyler, Waldrip, Young.

A presentation was made by Wyoming Attorney General Peter Michael. He highlighted the following:

- Currently there are 13 attorney vacancies in the office
- Focus on Professional Development
- Recruitment
- Prosecutor's Handbook Development
- Seizure and Forfeiture Legislation
- Wiretap Warrants
- Workers Compensation Appeals

The judges joined the local bar for a Law Day photo. The conference reconvened with the local bar and an open dialog question answer session between judges and lawyers was conducted. Adjourned at 4:00 pm.

The conference reconvened May 1, 2015 at 8:30 am. The following items were discussed for the good of the order:


- December Minutes were unanimously approved
- Treasurers Report was unanimously approved (Exhibit A)
- Boys State and Girls State volunteer opportunities were presented
- Discussion of Guardian/Conservatorship compliance
- Court Security Commission regarding the local District Court Judge chairing the respective county committees.
- W.R.Cr.P. Rule 41 changes that become effective July 2015
- WyUser field search handout was provided (Exhibit B)
- Judicial Salaries were generally discussed
- Law Clerk Salaries were discussed. The attorney general informed the group that the typical starting salary for an AG's position is \$62,000/yr.
- Judge Fenn reported on the Wyoming Supreme Court's visit to Sheridan and the positive experience which included an oral argument and You Be the Judge program.
- Judges Cranfill and Young reported regarding their attendance at the Legislatures Joint Judiciary Meeting in Lander. It was expressed that a representative from the District Court Judges Conference should try to attend any future meetings.

The conference unanimously adopted a resolution in support of the establishment of a fourth district court judge for the First Judicial District, Laramie County.

The conference unanimously adopted a resolution appointed Judge John Perry to serve on the Board of Judicial Policy for another term.

Meeting was adjourned and a tour of the Heart Mountain Interpretive Center was provided with Senator Al Simpson acting as guide.
